CUSTOMER DECLARATION / DECLARAÇÃO CLIENTE

This document regulates the general conditions applicable to the contractual relationship established between Global Refund Portugal Unipessoal, legal person 501-952.187, with registered office at Av. D. João II - n.º 46 5.º A, 1990-095 Lisboa, Portugal (Global Blue) and the Client identified above, for the purpose of providing "Refund Services", understood here to mean the fulfilment of all legal and formal procedures enabling the Client to be refunded the VAT paid on the purchase of the goods listed on the attached invoice, or the security deposit provided to the Shopkeeper at the time of purchase. Portuguese law shall apply.

By agreeing to be issued this Tax Free Form ("Form") to use the Global Blue ("GB") tax refund service:

- I declare that I have purchased the goods according to the goods description above, that my personal details are filled out correctly and that I am resident outside of the EU. I understand that the refund will not be made unless all mandatory and regulatory requirements are met.
- I declare I intend to hire Global Blue to, on my behalf, complete the administrative and legal procedures needed to confirm the VAT exemption on the acquisition of the goods described.
- I understand Global Blue charges a fee for the services provided and I accept such fees are offset against the VAT/security deposit to be reimbursed. An additional fee may be deducted depending on whether you require the refund paid in cash, to specific cards or digital wallets. For a non-cash refund in a currency different to the currency in which the Form is issued, GB will apply a currency conversion charge - accounts will always be credited in the billing currency of your account. - I agree that the Form must be validated by Customs at the point of departure from the EU, within 3 months after the month of purchase, and stamped Forms must be returned to GB.
- I consent to the processing of my personal data as stated in the Privacy Policy available in www.globalblue.com/term.
- I understand that this Form is the sole property of GB and that I have agreed to my refund being made by GB (or its authorised refund partners) only.
- I agree to the full tax free shopping terms and conditions, see www.globalblue.com/terms.
- I agree that if I do not claim reimbursement from Global Blue within 30 days after customs validation, Global Blue will reimburse the tax fee due to me under the terms of this contract, by issuing a prepaid credit card, registered and titled in my name, the issue of which will be communicated to the email details provided by me.
- I agree that the card will be issued free of charge, as well as its maintenance for a period of 6 months from its issue. Once this period has elapsed, I agree that the card will be maintained at a cost of five euros per month, to be deducted from the card's balance until the card's limit is exhausted.
